Registered work-based learning practitioners in Wales

The EWC is the independent regulator for the education workforce in Wales. Work-based learning practitioners have been required to register with the EWC since 1 April 2017. This is the first data to be published by EWC about this group and covers age, gender and employment. We will report on other characteristics like qualifications, welsh language, ethnic group and disability in the future, as our registrants populate their records on the Register. The data shown is as at 1 March 2018.

Number of work-based learning practitioners

Registered work-based learning practitioners work as trainers, assessors, tutors, coaches, or in management and quality assurance roles. There are no mandatory qualifications required to be eligible for registration in this category.

A work based learning (WBL) practitioner must be registered with the EWC if they provide work based learning services for, or on behalf of, a work based learning provider where the provider is contracted to the Welsh Government (this also applies to all sub-contractors and consortium members that deliver Welsh Government funded training).


Work-based learning practitioners make up 3.3% of all registrants on the EWC Register of Education Practitioners.

Age


The age profile of registered work-based learning practitioners is older than the age profile for all registrants.

11.0% are aged under 30, whilst 34.9% are aged 50 and over. In comparison, 19.7% of all registrants are 29 or under and 28% are aged 50 and over.


Gender



65.3% of registered work-based learning practitioners are female. The proportion of male practitioners in this sector (34.7%) is higher compared with the overall profile of the register (29.6%).

Employment



Most work-based learning practitioners (68.3%) are employed by private or third sector training providers (some of which may be associated with an FE institution but are registered companies in their own right), and 54.2% of those are employed by a sub-contractor or consortium member.

20.5% of work-based learning practitioners are employed by FE institutions. For 50.8% of these, the FE institution is a sub-contractor or consortium member.

11.2% of registered work based learning practitioners are not currently providing work based learning services as their main employment.
